**Holding & Pickup Agreement:** A \$500 non-refundable deposit is required to hold your spot on the litter /puppy. The breeder assigns the buyer the guarantee that the spot on the litter/puppy will not be offered to any party other than the buyer as long as the buyer adheres to picking up the puppy by 8 weeks of age, unless otherwise discussed. Transportation options are available at breeder’s discretion, arranged for an additional charge, which will include the crate and any necessary health documents. If your puppy is not picked up by the time it is 8 weeks old and no prior arrangements have been made with the breeder, the breeder has the right to void this contract and find another buyer, no refunds of deposit will be given. After your puppy reaches 8 weeks of age, a \$20 boarding/training fee will be applied to each day that puppy is not picked up. All fees are to be paid in full before the puppy will be released to the buyer.

**72 Hour Guarantee:** This puppy is guaranteed to be in good health, to the best of the breeder’s knowledge. If he/she wishes, the buyer has 72 hours from the date of taking possession in which to have the puppy checked by a licensed veterinarian. If there is a problem that cannot be rectified, the buyer may return the puppy to the breeder, at the expense of the buyer, on the day following the vet exam, along with a veterinarian’s statement defining the problem. The buyer will receive a full refund of the purchase price of the puppy as soon as the puppy is back in the possession of the breeder. (Exclusion: This does not include the presence of parasites or diarrhea, and also does not apply to a health problem resulting from an injury or accident due to transport or the buyer’s negligence). Any and all medical expenses are the sole responsibility of the buyer after the puppy leaves the breeder’s possession. Viral, bacterial colds, Kennel Cough or parasite infections such as Coccidia or Giardia, which are easily treated are not covered in the health guarantee as they are natural things puppies can pick up anywhere. Umbilical Hernias also referred to as “outie” belly buttons, Entropion, and Cryptorchidism are not covered in the health guarantee. The puppy will be assessed by a licensed veterinarian before leaving the breeder and will be treated for parasites and given age-appropriate vaccinations before they leave the breeder’s home. Prior to pickup, the buyer will be made aware of any health issues that are known to be present and be given the opportunity to back out of the sale for a full refund at that time. The breeder will not cover any treatment cost if the buyer decides to continue with the purchase and takes possession of the puppy. The breeder does not make any guarantee on color, size, fertility, working abilities, or temperament.

The buyer shall provide proper nutrition, vet care, shelter and exercise. The pup shall be socialized properly after all immunizations given, to include other people outside the family, other dogs, and strange places/noises. Obedience classes are recommended before the pup is 1yr old. Also, always keep a Golden Retriever reference book on hand to refer back to, please call with any questions, we want to help you.

**\*\*26 Month Guarantee:** The breeder offers a 26 month guarantee against genetic moderate or severe hip dysplasia, grade 2 or grade 3 elbow dysplasia, and affected genetic diseases including PRA-1, PRA-2, ICH 1&2, MD, NCL, and prcd-PRA disease. Because diet is such a large part of overall health, we recommend feeding a high quality diet. If a dog presents with the above-mentioned health conditions at or before 26 months, the breeder offers either;  
*Option 1.* A replacement puppy at half price if the buyer wishes to keep the affected puppy as a companion. Buyer must have the affected puppy fixed at their own cost  
*Option 2.* If the buyer would like a full replacement puppy at no cost, he/she must return the original puppy to the Breeder at the buyer’s expense.  
\*The breeder retains the right to evaluate the puppy at their vet as a second opinion prior to any replacements being made.

In the case of sudden death of the puppy within the first 26 months of his/her life, the breeder must receive a written notice of the puppy’s death from the owner’s veterinarian, along with an official necropsy report indicating the cause of death, paid by the buyer. If it is found via necropsy that the death was caused by a fatal congenital defect, the breeder will offer a replacement

puppy at no cost. If there is no necropsy done, there will be no replacement puppy offered. The breeder reserves the right to acquire a DNA sample and microchip scan from the puppy to determine the dog or puppy as one of our lineages.

- In regards to the health guarantee, the following ALL must be met:
  - 1. The original buyer must own the puppy- and it must be in their possession/live in their home.
  - 2. The puppy must not have sired or whelped a litter.
  - 3. The puppy must not have been under/ overfed. Body score completed by veterinarian.
  - 4. Buyer must show veterinary statement of necropsy, diagnosis of hip/or elbow dysplasia by the OFA or Pennhip, or results of “affected” genetic diseases through a genetic company, along with a copy of the x-rays or exam results prior to the 26 months of age.
  - 5. The dog must NOT have been fixed before the age of 18 months, unless it has been evaluated/recommended by a behavioral trainer and discussed with the breeder.

At no time will any monetary refund be given by the breeder.

**Limited AKC Registration Puppy Contract Details below will apply.**

This puppy is being sold as a pet on limited registration and therefore the following applies: The buyer agrees this dog will not be bred on purpose or by accident. If this dog sires or whelps a litter while on “limited” papers, the buyer agrees to pay the breeder \$500 per puppy born or forfeit ownership and possession of the dog and all offspring back to the breeder. Once this puppy has reached 24 months of age and has received all of the necessary health testing according to the Golden Retriever COE to receive its CHIC # and received at least one AKC title, full rights may be purchased for an additional \$1000 at breeder’s sole discretion.

- The breeder reserves the right to rescue this puppy/dog if it is found to be mistreated, neglected, or abused. Also, any mistreatment, neglect or abuse of the animal automatically voids all guarantees given by us.
- Breeder has the right to, at any time; decide to stop breeding Golden Retrievers. In this case, no replacement puppies shall be given and this contract is null and void.
- First Right of Recovery: If at any time the buyer is unable to care for or chooses to change his/her mind about caring for the puppy purchased, the breeder retains the first right of recovery. The buyer must notify the breeder as to the change in circumstances and give the breeder first chance to take the dog back before any other action is taken. The breeder will be given 7 days to make a decision if they would like to take the dog back or not. The buyer agrees that if the breeder decides to take the dog back into their possession, there is no guarantee for any refund. If any refund is given, it is the breeder’s sole discretion and will not exceed the puppy’s original purchase price, minus the deposit amount and any fees associated with taking the puppy back (transport, veterinary, behavioral training fees, etc.). This pup must NEVER be sold to a pet store, broker, puppy mill, or surrendered to a shelter. The breeder must be notified immediately of any problems that arise or if the buyer cannot care for the puppy/dog anymore.

**I acknowledge that this is a legal & binding contract and have reviewed and agreed to the terms listed above. Failure to follow the above contract per each section will result in “A Breach of Contract” and shall make that section of the contract null and void, following disciplinary action. This contract applies only to the original Buyer and is NOT transferable.**
